# APRIL 10<sup>th</sup> PROPERTY TAX DEADLINE FAST APPROACHING!

*Pay Early and Avoid the Long Lines*

San Diego, CA... San Diego County Treasurer-Tax Collector Dan McAllister today reminded San Diego County taxpayers that the second installment of their 2013-14 property taxes is due and will become delinquent if not paid by **Thursday, April 10, 2014.**

“Our branch offices are all ready to serve our taxpayers,” said McAllister. “As a reminder, the Downtown San Diego branch is the only office that will accept cash. Credit card payments are accepted online and by phone. To avoid credit card fees, pay online through our website via e-check. Pay early and avoid the long lines.”

As a convenience to taxpayers, all five branch offices will offer extended hours on **Thursday, April 10<sup>th</sup>, from 7:00 am – 7:00 pm.** Please note, paying by e-check on our website IS NOT the same as paying through your bank’s online banking system. Payments that are submitted through your bank may take up to ten business days before our office receives payment. PLEASE confirm dates with your bank before scheduling, to avoid penalties. Alternatively, please consider paying by e-check on our website at [www.sdtreastax.com](http://www.sdtreastax.com) – it’s free, fast & easy and your payment is credited as of the date of “submission”.

In September, 981,829 tax bills were mailed to San Diego County property owners. The 2013-2014 property tax bills are expected to generate \$4.8 billion. To date, only 30% of second installment charges have been paid and approximately 590,000 installments remain unpaid, for a total of \$1.68 billion.

Property tax bill payments are due in two equal installments: November 1<sup>st</sup> and delinquent after December 10, 2013, and February 1<sup>st</sup> and delinquent after April 10, 2014. Second installment late payments are automatically assessed a 10% penalty, plus a \$10 fee.
