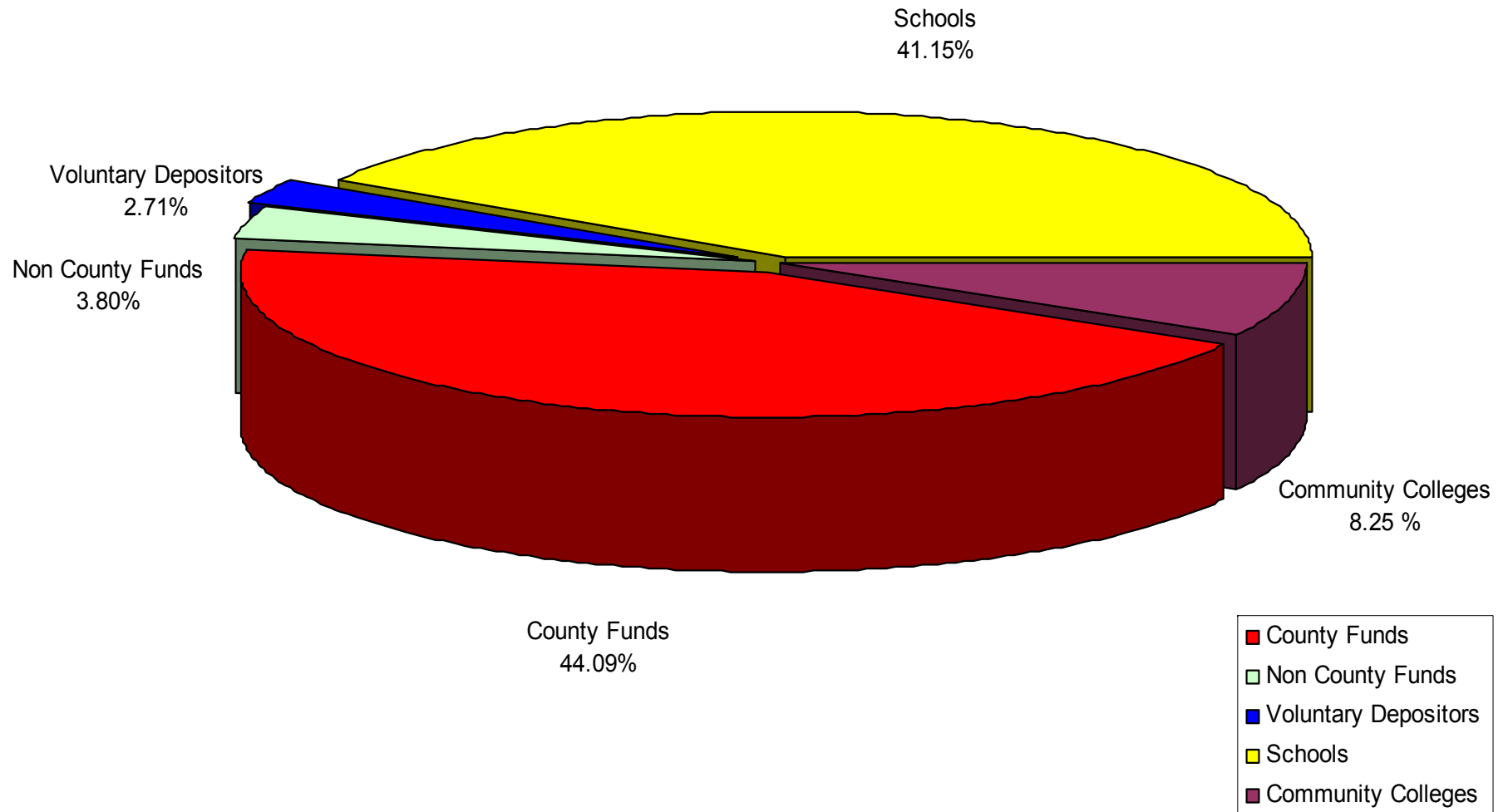

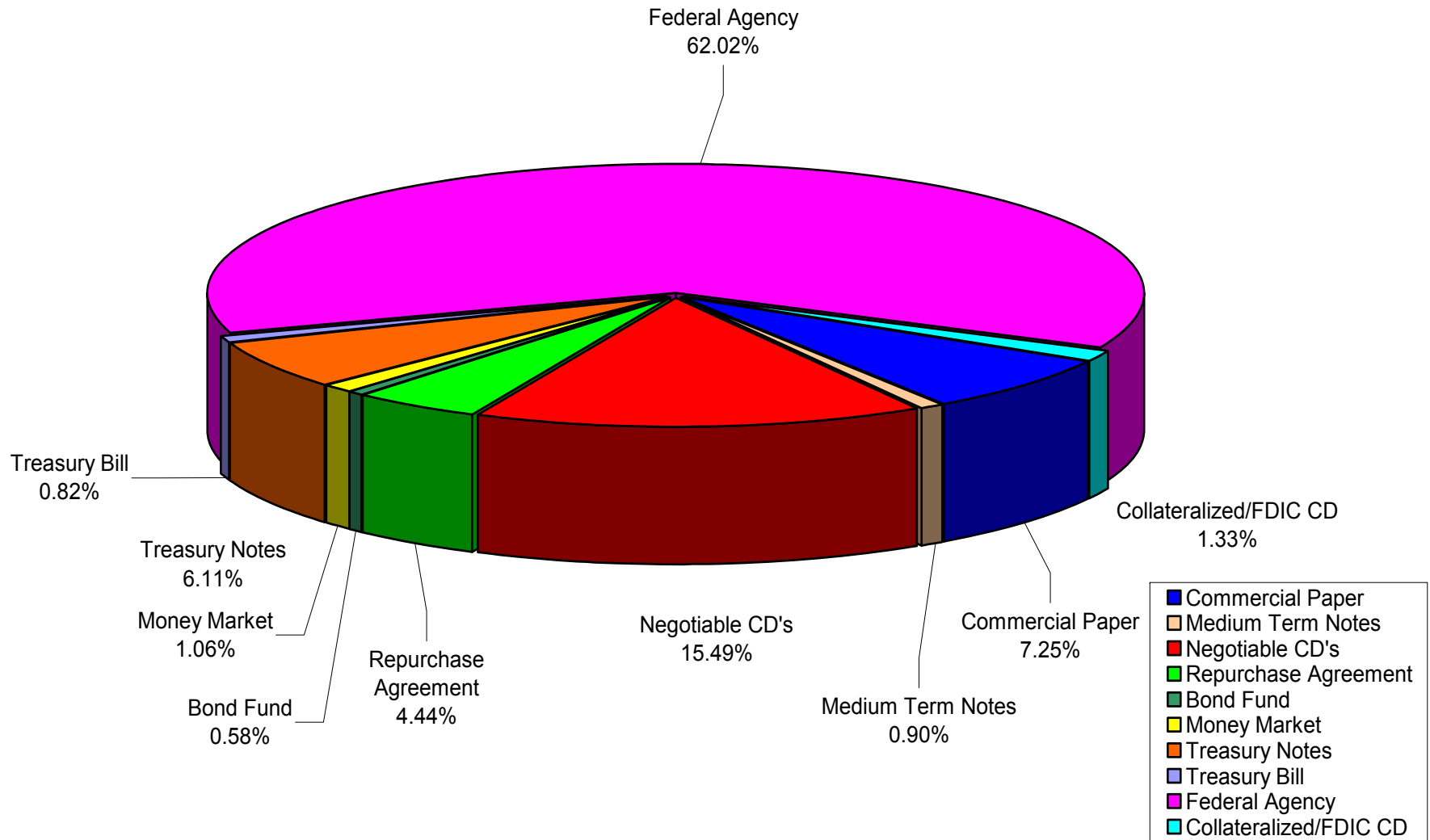

as of December 31, 2009



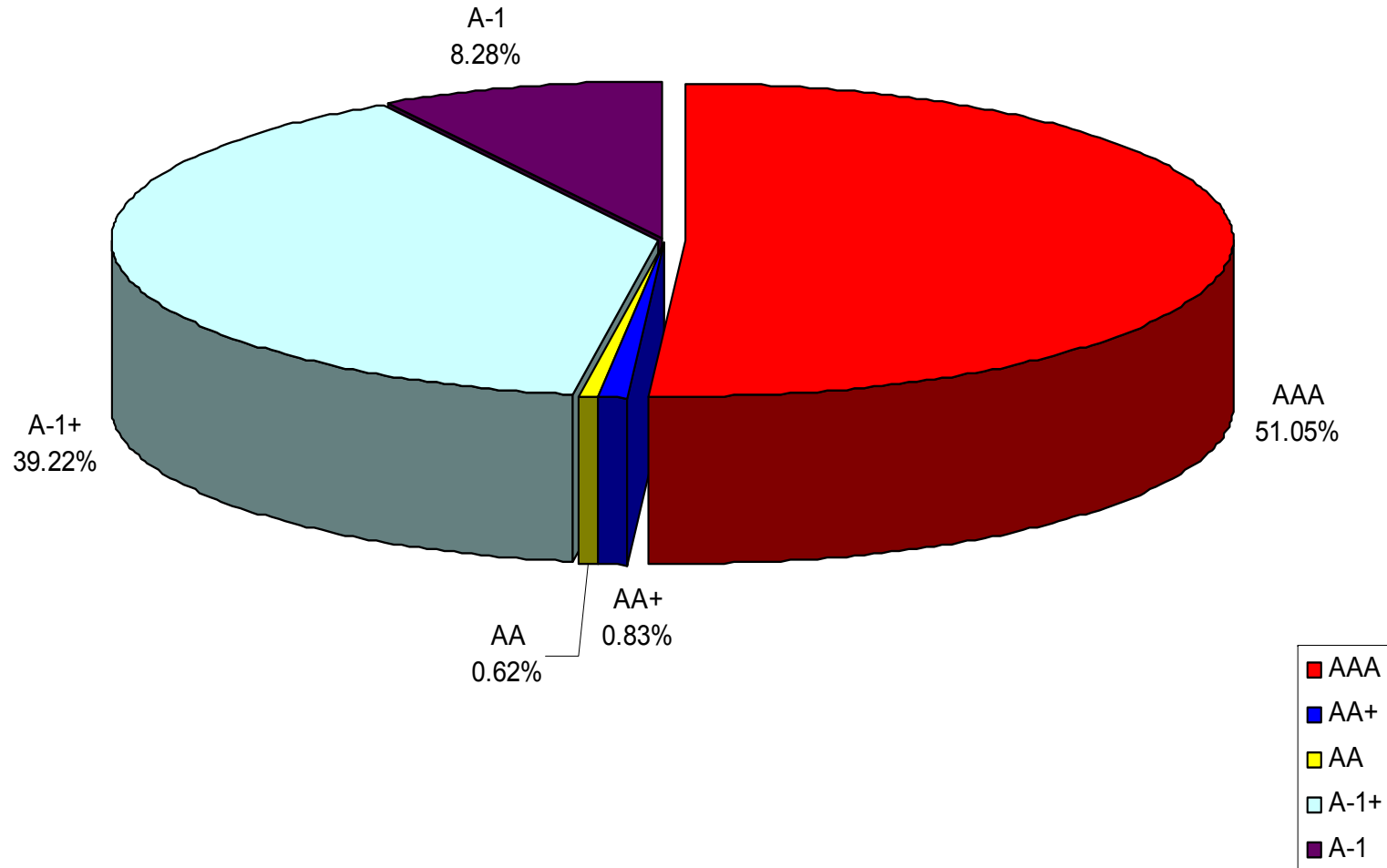
Pooled Money Fund - Asset Allocation
